## **Professional Learning**

1. PPM 8: Identification of and Program Planning for Students with Learning Disabilities:

Opportunity was provided to discuss this PPM and how we need to understand that Program Planning applies to any student who demonstrates difficulties in learning and who would benefit from special education programs.

#### **New Business**

#### 1. Special Needs Strategy Update:

Overview of the meeting that was held in Thunder Bay on October 5th with the various Service Providers, School Board Personnel, and Ministry was shared and discussed among the committee. The Special Needs Strategy has been created to advocate for an integrated service approach for students with multiple needs, to allow for seamless delivery. Although the Special Needs Strategy will allow for the seamless delivery between service agencies, we continue to have areas that are not able to access service and students who are on wait lists for service not for assessment. Unfortunately our current process is also not meeting the need for finite services as it is convoluted at best. Assessment is completed and then often consultative services are the only level of service that can be provided. We will continue to discuss and update as more information becomes available.

#### 2. After School Skills Development Program Application:

The After School Skills Development Program Application that Kerry submitted to the Ministry was shared and discussed. The communities that were selected for this application had at least 2 students on the Autism Spectrum within their schools that would benefit from additional opportunities to develop social skills with typically developing peers and further experiences to support them in gross motor skills development through after school physical activities.

#### 3. New Website Launch:

Kerry shared that the new website has been launched and continues to use the same address (<u>www.sncdsb.on.ca</u>).

#### 4. Service Provider Updates:

#### 4a) North of Superior Programs (Margie Rondeau):

Management team is currently in the second round of accreditation which enables them more legitimacy in the clinical community and thus more options for funding. The current manager, Neil Seich will be retiring in May 2017 and there is a current posting for two Regional Managers for the District. Two positions continue to be on a contract basis but NOSP is almost at full complement.

#### 4b) Community Care Access Centre (Helen Gibbons):

Organization is continuing with business as usual although there are some changes that will be occurring in the future. CCAC continues to provide support for students and families. There is a new referral form that became official on December 1st and it has been shared with all schools.

#### 4c) Norwest Community Health Centre - FASD (Maureen Parkes):

They have recently had a Grand Opening at their brand new building that has opened on Simpson Street in Thunder Bay. Everyone is invited to visit the Centre when they are in the city.

#### 4d) Dilico Anishinabek Family Centre (Jennifer Moore):

Dilico currently has two Mental Health nurses in the district, although they will be losing one soon. One nurse provides service along the North shore and the other in Greenstone. They are currently working on Case Management for the youth requiring service as they want to provide seamless delivery and not duplicate services. Dilico is also offering a Cultural Program in Thunder Bay and the District and can be accessed through client or non-client referral. Currently it has offered support for healings and circles, as well as a boys drumming group in Longlac. This is a relatively new program and they are in a process of recruitment.
