As of October 6, 2020, there were 80 students across our system participating in our Remote Learning program. Thanksgiving also marked our first formally scheduled time where students could transition back to their home schools for face to face instruction. Despite this being our original plan, we decided on providing more flexibility and transition to our parents and guardians as we began to understand the demands that remote learning was having. This was well received and the flexibility we offered was utilized by some families. Parents/guardians were asked to allow five school days to notice if they wanted to transition their child sooner so that appropriate safety protocols could be planned and adhered to.

Our Professional Development Faith Day session will be on October 23, 2020. Our theme for Faith Day is in full alignment with the theme for Catholic Education Week (May 2021) and is Nurturing Hope.

#### ii. Kerry Desjardins, Superintendent of Education Monthly Report

The Mental Health & Well-Being team continues to work collaboratively to support educators, students and parents. Well-Being Blogs are created weekly and then uploaded to the board website, social media sites and sent to Principals for sharing with parents.

The Mental Health Lead (Tracy Bryson) has been engaged in numerous collaborations and committees with the various service providers within our region that continue to offer mental health support to children and families in the District (e.g. Rural Education and Mental Health Collaborative, Greenstone Collaborative, Mental Health Leads Regional Collaborative, etc.).

All schools have received funding for their Breakfast or Snack Programs in their schools for the 2020-2021 school year. Due to COVID restrictions, these programs must operate very differently this year and September has clearly shown that the program will be considerably more costly to run this year relative to past years

#### iii. <u>Rima Mounayer, Superintendent of Education Monthly Report</u>

To support the implementation of a new Math Curriculum, a Mathematical Mindset Questionnaire was created by the Math team and will be conducted to collect qualitative and quantitative data on student's development of Social Emotional Learning Skills. This is a three-point questionnaire to be administered board-wide for students from grade 1 to 8 starting Fall 2020, Spring 2021 and Fall 2021.

The Reopening Plan is updated on an ongoing basis. These updates are brought on due to the constantly changing needs and information received from various sources. The



updates are always dated and highlighted in the document in order for staff and the public to have easy access.
