Ms. Vasanelli highlighted the learning that occurred at the August Principal meeting as well as the new Attendance Management System that will be piloted at Holy Angels School, St. Martin School and the Catholic Education Centre.

2. Student Achievement Monthly Report - Kerry Desjardins and Rima Mounayer

K.Desjardins and R. Mounayer updated Trustees on Learning for All updated resources; SEAC (Special Education Advisory Committee) September meeting and member recruitment; Mathematics resources to be used in all classrooms for the 2018-2019 school year; and the new Easy Connect Employee Self Service System being implemented for all Superior North Catholic School Board staff. Currently employees may only log onto the platform internally from a school location, however, it will soon be available externally.

Sr. Stephanie Romiti's report to Trustees highlighted her goals for this school year which will include: drafting resources to provide to teachers for school masses; preparing for the Fall Faith Day with our Catholicity team; providing curriculum resources for all grades; and continuing to be present in the schools to provide principal, staff and student support.
