- Mrs. McKinnon, Director of Education's monthly report included a New Pedagogies of Deep Learning Update, Faith Formation and Catholicity, Technology Enabled Learning Teacher Monthly Report and Indigenous Education
- 2. Student Achievement (Kerry Desjardins and Rima Mounayer)

Mrs. Desjardins, Superintendent of Education report was accepted as presented. Highlights included Learning for all, EQAO, and Early Learning. Special Education plan is focussing deeper on Math to align with Renewed Math Strategy. EQAO planning sessions with school teams have begun with Patricia Tapp.

Highlights of Mrs. Mounayer's report included New Teacher Induction Program, French as a Second Language and School Climate Survey. Matific is being implemented in all of our schools and teachers are excited to have this tool to assist with student achievement in Math. School Climate Surveys were completed in June 2017 and the results are currently be compiled and shared at the January Board meeting. Our Board will continue to ensure our schools are safe, inclusive, welcoming and diverse.

Mental Health and Wellness Report from Dr. Mary-Beth Minthorn Biggs and Math Lead, Peter Kutok and Aaron Baker Report were also shared with Trustees. Both reports indicate they have been travelling throughout our system and actively assisting educators and schools to with math strategies and mental health and wellness for our students.

3. Finance

Mr. Adams, Manager of Finance monthly report and finance report included updates of the work that has been happening and completed in the Finance department. As of November 6, 2017 the audit has been complete.

4. Supervising Manager of Plant & Information Technology

Mrs. McKinnon presented the Plant and Information Technology November monthly report on behalf of Mr. McKinnon in his absence. Acronyms from the report were clarified for Trustees. The purchasing of a portable for St. Hilary Catholic School in Red Rock is currently under review.

Library to Learning Commons are complete at St. Martin, St. Edward, Holy Saviour and Holy Angels. Our Lady of Fatima will have a sunshine/cultural room and St. Hilary will be



the fifth school to undergo this transformation. There is information on our board website on the learning commons transformations happening in our schools.
