- 4. Supervising Manager of Plant & Information Technology Monthly Report
 - Swipe card access will be complete by the end of September. Systems
 are installed in all schools, however training will be rolled out and
 complete by the end of September. Full time employees and contractors
 will have their own card, while part time (supply teachers) and volunteers
 will be given passes for each day they will be in.

Discussion regarding the demolition of the bricks at Holy Angels occurred. Mr. McKinnon informed Trustees that the demolition will begin in the spring. Dislodging of the duct and investigation has been complete, and in the spring of 2018 the work will continue. Radon Gas Mitigation question was raised. Mr. McKinnon informed trustees a second set of tests will begin in the winter of 2018.

St. Joseph Catholic School discussion on soccer field and nets. Mrs. McKinnon noted St. Joseph has been the priority school for two years. St. Joseph is a shared school and has separate playgrounds, and the goal is to build collaborative professionalism.

Clarification that the priorities shared by Principals reflect the work that was done in the summer, as reported in the Plant and Facilities report.

Principals have been working with Plant on the processes and procedures to request and get required work complete.



Learning Commons update was shared with Trustees. The Learning Commons in St. Martin is almost complete, St. Edward is under construction, Holy Saviour requires furniture and Holy Angels is underway. Furniture for learning commons has also been purchased for St. Hilary.
