Business Arising Out of Minutes

Professional Learning Update

1. Jordan's Principle Presentation

Stephanie and Artiga from Indigenous Services Canada led us through the attached presentation where she shared how services could be obtained for First Nation students regardless of where they live. They shared that the application form can be completed by schools or parents, but must include Status registration number, Band membership and consent must be obtained from parents.

Stephanie and Artiga explained how applications can be done for individual students or can be group applications if there is a similar need. These applications can include requests for Transportation, Psychology or Psychoeducational assessments, Speech/Language services, Art Therapy, Landbased Cultural supports directly from First Nation community, Summer Learning opportunities, etc.

Applications are completed for services from April 1st to March 31st but extension can be granted for the remainder of the school year received (e.g. funding for educational assistants ends March 31st but an extension can be obtained for April 1 - June 30). It is important that applications are fully completed prior to being emailed to the Ontario Regional office as a complete application can be approved and processed quicker.

- 5. Service Provider Updates (if available):

North of Superior Programs - Nicole Beaulieu Nicole shared that the North of Superior Program website is available and active. NOSP staff have been extremely busy as Seema, the counsellor hired through the NOEL project is currently on leave and her caseload (34) is being carried by the current staff with additional referrals continuing to come in.

A third manager has been hired for the Schreiber/Terrace Bay/Marathon/ Manitouwadge area, Karen Barclay. At this time there is not a youth counsellor available in Manitouwadge but an interim plan to provide service through Family Support is available.

Local Health Integration Network - Helen Gibbons Not available for an update.

George Jeffrey Children's Centre - Gilbert Rondeau Not available for an update. Children's Centre Thunder Bay - Fred Schmidt Fred shared that there are no current updates at this time.

Norwest Community Health Centre (FASD) - Maureen Parkes Not available for an update.

Dilico Anishinabek Family Care - Jennifer Moore

Jennifer shared that Dilico has revitalized their Walk In Clinic on the first or last Tuesday (depending on the community) every month. This is occurring in every office from 1:00 pm to 3:30 pm and is intended to be a single session for brief intervention. Nancy McGuire is travelling to the First Nation communities to provide service and is consistent in her visits.

SNAP is continuing in Long Lake 58 at the Eagle Nest but it continues to be hard having parents involved in the program.

Jennifer shared that Dilico services now include Three C's and Seaway which provide safe and secure housing supports for clients post treatment. In addition to housing supports the services will provide one on one counselling, case management, life skills, and cultural programming.
