Business Arising Out of Minutes Professional Learning Update

1. <u>Mental Health Lead Presentation</u> - Tracy Bryson (Mental Health Leader)

Tracy shared the attached Mental Health Presentation and included information on goals and programming, including the one-year action plan. As she is new in the role, she would like to concentrate on building relationships - committee memberships. One of the main goals from last year was to identify one person per school to sit on the Mental Health Champion Committee. Some schools have identified teams. These champions/teams will work in collaboration with the Mental Health Lead. This will ensure we have the proper training in our schools. October 28th will be the first meeting, including Safe-Talk training for all members. This way we will have at least one person trained at each school location.

Positive Behaviour Support Workers have been hired. This gives us one support worker for each of our 3 schools, with the main goal being supporting the facilitation and development of our Student Success Plans.

School Mental Health Ontario is funded through the government to support the implementation of mental health in our Boards. Each Board has a mental health coach.

Internal/external pathways - the board is looking to establish internal and external pathways - Positive Behaviour Support Workers and the next steps in referrals. We are working to ensure there is a clear system in place.

Fred Schmidt provided positive feedback on Tracy's presentation. He shared that the Ontario Child Health Study results from 2014 indicated more children and youth were seeking mental health assistance. Fred will share a brief summary of this study with Tracy and Nicole and other SEAC members.

Nicole Beaulieu thanked Tracy and gave positive comments on the relationships and collaboration that is happening in our schools.

Bobbi-Lin Mercer from St. Joseph School, indicated she would like to join the mental health team at her location. Tracy to follow up with this request.

New Business

1. After School Program 2019-2020

We have been approved funding for the following three years for the After School Program. The schools in Manitouwadge, Terrace Bay and Red Rock have secured a provider to run this program. Kerry will check with Principals in the remaining schools to see if they may be able to secure a provider for this program as well.

Students with ASD and typically developing students are involved in this program to develop social and peer relationships outside of the regular school environment. It has been very successful in the three communities that are currently operating the program.

2. SEAC Brochure and Recruitment Poster

SEAC Brochure - people that are interested in attending/joining SEAC, will be sent a brochure.

Recruitment Poster - This poster describes the role of SEAC, with contact information included. The poster will be added to our board website and sent to all schools.

We will look at having representation of an Educational Assistant on the committee. This will be discussed with school principals. We are anticipating that by the November meeting, we will have an E.A. representation.

4. Parents Guide to Special Education

The Guide is not changing, but we have added an addendum with a link to our names and organizations that are represented on SEAC. The online version will include this link.

5. Multi-Disciplinary Team Update

Our first meeting was held on our Professional Development Day. Referrals for student support are being received. The team will meet every second Friday.

6. Developmental Trauma and FASD Training Event

Training information was shared with the committee. An invitation to attend was sent to Principals to share with their staff. We have four staff that will be attending. The information from this training session will be brought back and shared with staff at their schools.
