

New Business

1. Elections:

2. <u>CPIC Members 2019-2020</u> - updated list and CPIC meeting plans

Ms. Mounayer reviewed the CPIC members list for this year and is pleased with parent attendance at the teleconference meeting tonight. We will ask Principals to promote these meetings with parents at their schools.

3. CPIC Funding

We have \$5,098.00 in the budget for this school year. Ms. Mounayer asked for suggestions on how to utilize this funding. Some ideas mentioned were parent resources, guest speakers though zoom video, using the funds by different school locations annually. It was suggested to move this item to the next meetings' agenda so we can take the time to review what this funding could be used for.

Ms. Figliomeni suggested a presentation from Dr. Alex Russell, a psychologist who speaks to parents and educators on anxiety, helicopter parenting and building resilience in children to name a few or the Third Path relationships, could be a couple of ideas. Kim will gather further information on this presenter and share the information at the next meeting.

4. PRO Grant Funding 2019-2020 - \$2,848.03

Ms. Mounayer described the current PRO grant information. We have created an application form with a memo to be sent out to Principals and School Chairs. There is also a report to complete at the end of the school year. This will be explained in the forthcoming memo. Three projects from 3 schools will be considered. The deadline for submissions will be December 13th. Senior team will review and decide on the three schools.

5. <u>Board Improvement Plan (BIPSA) 2019-2020</u>

The Board Improvement Plan is usually done in collaboration with staff and senior team.

Math is the biggest concern for our board. We have Report card data, EQAO data, Prime math program data that was implemented last year, which has been reviewed. Mental Health and Well Being goals and Catholicity goals are also included in the BIPSA. It was submitted to the Ministry at the end of September and is currently in the implementation stages.

6. Faith Day

All staff attended the Faith Day session which began with a Mass with Bishop Colli officiating alongside Monsignor Pat Stilla. After Mass we had a presentation by Monsignor Stilla on the Catholic Education Week theme of "Igniting Hope".

7. Celebration of Excellence

On Faith Day during our lunch break, we took this time to celebrate our staff years of service ranging from 5 years and more. We also celebrated our retirees as well as our

Good Shepherd Leadership Award recipients. This year we had five staff members that received this award. There was positive feedback from the staff that attended. Ms. Deroy commented that it is a good idea to combine these two events together on the same day.

8. Mathematics PD Day

At the end of September we had an Achieving Excellence in Numeracy Professional Development Day. Due to the Math funding decrease, this session was school based with the Agenda and topics predetermined by the Math Committee. This was presented with our new Zoom conferencing system to all schools, with the remaining of the day teachers working on the information that was shared.

9. New Board Office Building

Under the Accessibility Act we need to be compliant in having our building accessible by 2025. Because of the high cost of renovation to the existing building, a decision was made to construct a new Catholic Education Centre building. Staff are currently in the process of moving to the new location.
