## 2. Mental Health Update - Tracy Bryson

We recognize that relationships and connections are key and we realize we can not support students alone so engaging with community partners has been a priority. We continue to meet on a biweekly basis. Meetings are arranged with NOSP and Dilico around Wellness Wednesdays. We are hoping to bring this back in the coming months. We now have a data collection system that allows us to provide programs to our students. We continue to offer parent workshops. We had a session with Sheri Bartman and she continues to provide support to our Principals, Educational Assistants and staff. We were provided with an Action Kit for educators which will be shared with Principals.

PBSWs are continuing with the blogs and school support has been the primary focus.

#### 3. Professional Learning Update - Special Education - Kerry Desjardins

Unfortunately in Special Education and most areas, we have not been able to do a lot of Professional Development due to the lack of supply teachers, as a result of COVID-19. We had a Professional Development Day on Friday January 29th, with teachers involved in an assessment day and the Educational Assistants and Principals attending a morning session on understanding Autism and ABA through the George Jeffrey Children's Centre, as well as a session on supporting students with Speech/Language needs. The afternoon session had the same participants, including the Mental Health and Wellbeing team involved in BMS Training.

## 4. ISNC Funding 2020-2021 - Kerry Desjardins

We have received funding from the government for services for students that require assessments. The ISNC funding is also being used in supporting students with TinyEYE Therapy Services and Superior Speech Services.
