## **Professional Learning Update**

#### 1. Mental Health Update

The partnership with Children's Centre Thunder Bay has been ongoing. Counselling services have been for two days per week. They are approaching a full caseload at the moment. We are confident that wait lists will move along given the service being offered is brief with using a 4-6 session service model. Dilico staff continue to offer virtual programming throughout the School Board. Trauma Informed Training will be presented to specific schools within our Board. On March 23 and 24, we will be offering the ASIST workshop for staff. There will be a training session, Mental Health First Aid First Nations, hosted by Superior Strategies and SNCDSB on April 25, 26 and 27.

2. Special Education Plan 2021-2022 - Consultation & Feedback - K. Desjardins

We will begin reviewing our Special Education Plan for the 2022-23 school year. Please review the 2021-22 Plan and provide any feedback to K. Desjardins. We would like to finalize our plan by the May 3rd SEAC meeting.

3. Education Funding 2022-2023 - K. Desjardins

Minister Lecce has announced the education funding for the 2022-2023 school year. The link to the memos from the Ministry has been shared with members. We will be receiving more funding information in March. Some funding can begin being utilized in April.

4. EQAO 2022 - K. Desjardins

EQAO Testing will resume this year. This is an opportunity for students to test their own abilities. We are working on our communication to parents to help to alleviate any stress on their children. The testing will be done in a digital format.

5. Project Inclusion from Holland Bloorview - K. Desjardins

This is a child rehabilitation project, with educator modules on disability, accessibility and inclusion. This will be reviewed at a later date for our Board.
