2. School Start Up

Our schools look amazing! Many capital projects have been completed at many of our schools. Open House last night at St. Edward School was a great event. The Ministry of Education has also put out a plan to "catch up" from the impact of Covid-19. We have purchased the Lexia Training Program and provided training for our staff. Each school has a Lexia implementation plan. Preparing students for the jobs of tomorrow was also an area of focus. All teachers were required to complete an online Sexual Abuse training session by September 15, 2022. We do have staff shortages and are working diligently to fill these positions. We have added Vice Principal positions in a number of our schools.

3. Say it First / SGDSB Partnership

We have a pilot project in partnership with Superior Greenstone DSB.

The students were very receptive to this program. What students learn with our Board also coincides with SGDSB. The program has 120 modules. It's easy to learn and students can complete modules at home. We will share more information on this programming at a future IEAC meeting.

4. National Truth and Reconciliation Week Programing support

Resources in support of National Truth and Reconciliation week were shared with all staff. This is to support teachers and student learning. Some other age appropriate books were also linked in the document. One hundred students have signed up for the Orange Shirt beading activity. This year we purchased a virtual event assembly on the truths and journey of Q-Mack. Many schools have also done their own planning events. Invitations have been sent to First Nation

communities to attend their local schools' events.

5. Orange Shirt Logo Contest Criteria

Current IEAC input:

IEAC would like to judge the original artwork. Keep the year off of the design. The orange shirts aren't meant to be worn only on the 30th. Once the logo is selected, we will get them processed with a company that will share proceeds to the Truth and Reconciliation legacy. Discussion as to whether to frame the winning artwork for the student. Perhaps recognition of all student submissions would also be nice to do.

Previous IEAC input:

 Would like to keep it confidential regarding which school the design comes from or not knowing the student name who designed the shirt.

Criteria to include:

- Must attend the school and in grade K to 8
- Original Artwork
- Must be only 2 colours
- Must be made to go on a t-shirt
