- **a.** Summer Learning Presentation, Sarah Clowes, Vice-Principal, St. Edward Catholic School and Lindsay Costa, Principal, St. Martin Catholic School
  - i. <u>Summer Learning Presentation 2022</u>

S. Clowes shared an amazing video presentation on Summer Learning and the highlights of the Program with a focus on numeracy and literacy.

#### b. Director's Report, Maria Vasanelli

The Director welcomed R. Mounayer back to our team. Our school start-up went very smoothly. Our schools look amazing with the renovations and new look. It shows a nice welcome to our schools. The Director shared the Ministry of Education's "catch-up" plans and preparing the students for the "jobs of tomorrow." The support for student's mental health is a continuation of what we are already doing.

In regard to Truth and Reconciliation, we are working in support of this initiative. Unfortunately, our Board is limited with staffing.

Our staff have been completing the requirements for the Sexual Abuse Prevention Program training.

Focus on the Future - we have the funding and are planning for the St. Hilary School expansion.



Succession Management - Two Vice-Principals have been hired at St. Hilary and St. Edward Schools. St. Joseph school Principal is Carlo Porretta, and we are advertising for a Vice-Principal for Our Lady of Fatima School. We have hired Karin Patock as Assistant Manager for Plant and Operations. Changes to our CEC operational positions have also occurred. We continue to be a 21st-century board with our technology.

Student achievement is very important to our board, and we are in the process of retrieving data for students in the Math program. We are currently short a Math Lead position and are advertising for this placement.

Safe Schools information has been shared with schools, and we would like to provide professional development to our staff.

## iii. Paul Tsekouras, Superintendent of Education Monthly Report

We had a very busy start to the school year and have completed school visits. The Catholicity in our schools will be under the direction of Ben Jewiss.

We have hired an Indigenous Education Lead recently Ashley Muir. The first IEAC meeting will be held on September 22nd. The "Month at a Glance" pilot project was shared with Board members.

P. Tsekouras shared the information on the hiring of two new Vice Principals S. Clowes and B. Jewiss.

We have started an Academic Council to collaborate our system portfolios within our Strategic Plan. We do not have a remote learning program for this school year.

### d. Finance

## i. George Scott, Manager of Finance Monthly Report

G.Scott mentioned our enrolment as 685 for the school startup. Mr. Scott shared that our student enrolment has increased which is an encouraging sign. In September we need to report on student numbers in our classrooms. We need to be compliant with our classroom sizes. We have 3 primary classrooms that have over 20 students.

Finance is preparing for the year-end financial audit. Auditors will be here in late November.

G. Scott shared the financial report as of September 14, 2022. The question came up as to whether we are billed for days that the bus is cancelled.

Over the summer, the IT department updated devices to be ready for the new school year. School servers were updated as well as classroom interactive equipment.

Website Job feeds were also worked on. The power generator for the Catholic Education Centre/St. Martin School is scheduled for the Fall.

B. Biggs shared updates on the great improvements and updates that were made at each of our schools. We are having a problem with parts and products being received.B. Biggs shared the roles and responsibilities for our new hired Assistant Plant and Field Services Manager. All preventative maintenance has been completed on our heating and air handling systems.
