## 4. Declaration of Pecuniary Interest

### 5. Reports

#### a. Student Achievement

- i. Kerry Desjardins Superintendent of Education
  - Moving forward with the Confederation College professional development for Educational Assistants. The first sessions are to be held on November 24, 2022. We are hopeful that the registrations will continue to come in in the next couple of days. We look forward to this new partnership with Confederation college. This voluntary training is for both our unqualified and qualified EAs.
  - 2. St. Edward Catholic School in Nipigon is now offering an afterschool program starting December 1, 2022. The programs in both Terrace Bay and Manitouwadge are successful and at max capacity. St. Hilary is also actively trying to recruit staff to run an afterschool program.
  - 3. Children's Centre in Thunder Bay New counsellor for two days per week. Uptake in referrals coming in as we emerge out of covid and there is a need in our communities. Sarah will be joining us beginning next week.
  - 4. The SNCDSB has partnered with Superior Strategies and the Royal Commission of Canada to offer our staff training in Mental Health First Aid First Nations. We are in a staffing



crisis, and a lot of schools did not have coverage to join for the three days of training. Kirstine Nicole Baccar from Superior Strategies did an incredible job of ensuring content was understood in a meaningful way. 14 people from Superior North Catholic District School Board took part in learning, including K.Desjardins, T.Bryson and J.Wawia.

- Process for Jordan Principle EAs was discussed. Jordan Principle funding is from federal funding and the time of application approval depends on the intake worker. Some applications are processed quickly, and some take longer. The Learning for All teacher works with families to create the application.
- 6. With children lacking socialization skills because of COVID, language programs will come back. K.Desjardins met with Karen Figliomeni from Superior Speech Services regarding services from K-2. We will have to be creative about how we will get this learning happening due to the lack of staff.

#### ii. Rima Mounayer - Superintendent of Education

- Working on developing teacher abilities and skills, answering their specific needs, and moving forward in the new normal to get back into classrooms for students and teachers. Actively collecting data from our teachers to see where our students are at. Report cards and EQAO - getting MATH PRIME Data, a new Literacy program that gives us data to meet the students where they are and move them forward and ensure staff and students feel safe.
- 2. Release time is a challenge, and finding models that bring Professional Development for educators into the classroom while there is also student learning.
- 3. Provided New Teacher Induction Program (NTIP) orientation for new teachers and offered to mentor them. Challenge finding mentors as this is voluntary basis.
- 4. Math Professional Development Day will be held on November 18th through zoom due to feasibility reasons. Offering specific Math PD to our EAs and FSL and NSL teachers. This way, it is relevant to professional



development for all.

- 5. Peter Kutok is working with students in the north, going into classrooms and offering support in Math and Literacy.
- iii. Paul Tsekouras Superintendent of Education
  - Faith Day was held on October 24th. Wonderful to have sister school communities have their retreats together. Together staff discussed how to make Catholicity more visible in our schools and look at Catholicity resources. Schools will be sent advent materials, including Halo and consumables for classrooms and prayer tables.
  - Hired a Technology Enabled Learning Teacher, Cara Figliomeni, who started November 1, 2022. C.Figliomeni will work with Technology Lead Sarah Clowes and the Ed Tech team to support the schools with a focus on digital tools and resources and will champion digital portfolios for our students.
  - 3. Second Indigenous Education Advisory Committee (IEAC) meeting was held on November 4, 2022 face to face. It was wonderful to be together to reconnect. Beginning to plan the PD day for Indigenous education on April 21, 2023. We look forward to these opportunities continuing.
  - 4. The IEAC committee invited Trustee Lafrance to join the subcommittee meeting on November 29, 2022.
  - 5. Religion curriculum is taught in all grades as part of the curriculum. Our school Faith teams look at how we standardize the resources and provide support for teachers. The Halo is a plug and play for activities created for teachers to use in their classrooms. Ben Jewiss and Paul Tsekouras will be making a schedule to go in and visit the schools to support them. P.Tsekouras will ask for a religious schedule that happens in each school. Churches have low attendance at masses, and schools are one of the places where students are getting religious programming and attending school masses. Religious programs have a teaching guide that is followed. Superior North Catholic District School Board is an inclusive Board. Schools are reconnecting with



parishes following COVID. Growing in Faith and Growing and Christ is the program being used and has been updated from the Fully Alive Program.

#### **b.** Finance - <u>George Scott, Manager of Finance</u>

- i. Grant reporting for 2021-22 is almost all wrapped up. Extra grant money was received for covid, including additional staff and transportation, which has ended as we move forward.
- ii. Trustees who ran in the 2022 Municipal Elections have to report on campaign costs. This has to be reported even if it is a NIL report. Contact your municipality, and they will assist you in how to report this.
- iii. Audit committee report update received from Regional Audit. Three recommendations were satisfied, and all three recommendations were addressed.
- iv. Safety on buses will be presented at the next audit committee meeting. The Cybersecurity will also be presented in the coming months.
- v. Year-end audit is wrapping up. Ministry financial package will be submitted to the Ministry. Audited Financial statements will be presented through the next audit committee meeting scheduled before our next Board meeting.
- vi. Revised estimates will be presented in January.
- vii. Student enrolment is currently up.

### c. Information Technology - Billy Luby Monthly Report

- i. A new device is being prepared for the new Trustees.
- ii. A cybersecurity audit is being conducted. We submitted an insurance report to our insurance company that found policies and multi-factor authentication that need to be looked at.
- d. Plant & Field Services Barry Biggs, Plant and Field Monthly Report
  - i. Breaking ground at St. Hilary Catholic School at the end of May.



B.Biggs will work with the school on how the logistics will work.
