### 8. Presentations

### a. <u>Principal Presentation</u>, Lindsay Costa, St. Martin Catholic School

 K.Desjardins thanked Lindsay Costa for her presentation, noting that it is evident from L.Costa's presentation that staff and students are engaged in the initiatives.
 K.Desjardins and Trustee Wawia thanked L.Costa for her leadership in the school and for making all feel welcome.

### b. Director Report, Maria Vasanelli, Director of Education

- A Save the Date email from OCSTA about the upcoming Program in Human Rights for Catholic School Board Leaders, a program designed for Trustees in collaboration with the Ministry of Education and the trustee associations to inform its design and delivery. OCSTA has gotten on board to educate Trustees about what is happening provincially and in education in general. These are good sessions for Trustees to attend. This program will consist of two sessions. Session 1 topic is Ableism and is planned for Saturday, May 13, 2023 from 9:00 am -12:00 pm. Session 2 topic is Anti-Hate and is planned for Tuesday, May 23, 2023, from 5:30 pm 9:00 pm. More information will be provided once it is available.
- The Senior Team has to take a different approach and mindset to education. This is at the top of the agenda in all areas of education at this time.
- A presentation on the Brightspace Portfolio will be put together. Principals have also been asked to put together a presentation n how schools use technology as a tool, and findings will be shared with Trustees.

#### c. Student Achievement

- i. <u>Kerry Desjardins, Superintendent of Education Monthly Report</u>
- The intentional work being done in the Boards and schools and looking at the recommendations that have been made in the Human Rights Right to Read Report. Looking at ensuring we have supports in place in the early years so we do not see impacts early on. Early screens were done in January in all Kindergarten classrooms to determine what students were not meeting expectations, and intentional interventions are being implemented to reach these students.
- Two candidates from Lakehead University are doing placements at Our Lady of Fatima and St. Joseph. Both have temporary teaching certificates and can be paid for their placements at our schools. They will start March 20 April 28, 2023.



The hope is that they will continue after the placement is finished on April 28, 2023.

- The Board enters into a lease agreement every three years with the Corporation of the Municipality of Greenstone.
- Kindergarten registration is going well, and Welcome to Kindergarten nights are happening at all schools. Our registration numbers are much higher than they have been over the past number of years.
- The seven students that are waiting for referrals for the Children's Centre Thunder Bay are due to short staff; students have been tiered and are being looked at based on their needs.
  - ii. Rima Mounayer, Superintendent of Education Monthly Report
- It is the Human Right of students to have the right to learn, achieve knowledge and succeed. Our Leads and Principals work in their capacity to ensure we are answering the needs of our students. Targeting higher level thinking for our students. We are incredibly proud of the work our Leads are doing in our schools.
- Positive feedback has been received from the families who attended the Lakehead University Achievement Indigenous Cultural Celebration Night. The event celebrated Indigenous culture and featured a special jersey created by a local Indigenous artist, Jacenia Desmoulin.
- Attendance support for families continues. We see a lot of refusals for students to attend school. These refusals are based on non-diagnosed anxieties the students have to come to school. Attendance Counsellor is working with these families to provide services with partner organizations, Triple P programming and incentives to get these students back to class. The absenteeism rates for students range from all grade levels.
- Trustees can put a letter together to bring the attention to the Ministry about where the kids are removed from the registry. Trustees could bring this to a regional meeting to request changing the registrar rules so that they do not demit after 15 days.
  - iii. Paul Tsekouras, Superintendent of Education Monthly Report
- All schools and the Catholic Education Centre have celebrated Shrove Tuesday and Ash Wednesday. The feedback on the HALO has been qualitative. Working the see how we can track who is using it and how it is being used within classrooms.



- Brightspace Portfolio launched and has 483 parents/guardians log in to see what their kids are working on. This is an excellent level of parent engagement.
- Planning an Experiential Learning Opportunity with the College for our St. Edward and St. Hilary Catholic School students to experience life at the college for a day. Transportation costs are a factor in offering this to other schools within our Board. We must look at how we can integrate this opportunity with other events already planned for our schools in the city. An idea might be to partner with other school boards to share transportation to attend a day at the College or the University.
- Indigenous PD Day is on April 21, 2023. The day is coming together, and content from the morning is being tied in for educators and staff to make the learning visible within the schools. The subcommittee meets tomorrow, March 9, 2023. The day will be interactive, and resources will be on hand to view. The plan will be finalized and shared at the next Board meeting.

#### d. Finance

- i. George Scott, Manager of Finance Monthly Report
- Work begins on the 2023-2023 Estimates. Once GSN information and staffing numbers are completed, it can begin and will be brought for approval at the June Board meeting.
- School fundraising accounts are being reconciled, and it appears fundraising activities are getting back to pre-covid levels.
- An update on Capital projects will be brought to a future Board meeting.
- A professional development session on Trustee Travel was done with Trustees.
  An example of a travel trip was provided. Best to keep receipts for everything. Do not require receipts for anything outside Board boundaries (including Thunder Bay), and submit per diem. Get a receipt from the hotel, even if it is on a Board credit card, as they are required to keep these on file for audit purposes.
- On the travel expense form, dollar signs should be added to the allowance rate chart to avoid confusion. The numbers listed are amounts for round-trip costs.
- Each line on the travel expense form is a trip. Trustees are required to combine all trip expenses on one line. Expenses can be handed in monthly or when attending a meeting.
- Inside Board boundaries, you claim receipt and only get the amount you claim.

- SchoolMessenger and SafeArrival training was completed with Administrative Assistants and Principals, and the program implementation with parents and guardians are going well.
- Report cards and special programs have been completed through our Student Information System.
- Trustees will be receiving new devices; they will be Chromebooks. Training and support will be provided once they are received.

- i. Barry Biggs, Plant & Field Services Manager Monthly Report
- St. Hilary Addition program is still waiting for word back from the Ministry on what we are approved. If we do not hear by April, we may have to postpone the addition.
