8. Presentations

- **a. Principal Presentation**, Terri Harmer, Principal Holy Saviour Catholic School
 - Trustee Wawia and K.Desjardins thanked T. Harmer for her presentation and her leadership. T. Harmer is instrumental to the Holy Saviour staff members and students, allowing them to learn and ensuring they meet their academic and well-being needs.
 Despite challenges throughout the year, the school and educators have done incredible things.

b. Director Report - Strategic Plan Updates, Maria Vasanelli

- Ms. Vasanelli noted that the monthly Principal presentations throughout the 2022-23 School year highlighted the learning happening in our schools. Our Strategic Plan guides the school teams, and everything we do sets up our schools for success. Leadership on psychological safety is essential, and we must ensure we provide an environment where our staff feels safe, welcome and safe.
- All strategic plan pillars are evident in our year-end report. You see this happening throughout the year in departmental and monthly Superintendent reports.
- Math Up specialist Doug Duff will continue to work with our staff in the 2023-2024 School Year. Mr. Duff is an educational consultant, Principal, and Instructional Leadership Coach working nationally and internationally with school districts on school improvement.
- Reach Ahead Pilot Credit: This is an important project for us, and we want to ensure it is successful. This is a pilot for an opportunity to provide credits to our students graduating from grade 8.
- J. Wawia can be an elder and advisor for the Indigenous Education for our Board. The Board provides as much PD and resources to our educators as possible. Marlo Beaucage continues to be a resource for our schools following the April Indigenous Education Professional Development Day.
- Request to add the Trustees in the SchoolMessenger communications for school events and activities for the next



school year.

 The Senior Team is presenting on Senior Leadership at the Canadian Association of School System Administrators (CASSA) conference in Victoria, BC, and their presentation will be presented to Trustees in September. CASSA is the national network of senior school system leaders.

c. Student Achievement

- i. Kerry Desigratins, Superintendent of Education Monthly Report
 - Summer Learning Discovery boxes have been delivered to schools and are being provided to the program participants by Principals.
 - Kindergarten enrolment has been going very well, and ongoing communication continues. We are very visible in our communities through online platforms, print and television. Based on numbers, Holy Saviour and Holy Angels Kindergarten classrooms will have an Early Childhood Educator in their classrooms in the fall of 2023.
 - Our Lady of Fatima School is advertising for a Kindergarten teacher. We expect the registration numbers will consistently grow before the new school year.
 - The updates to the Special Education plan noted that the Ontario Special Education Tribunals now only offer virtual services.
- ii. Rima Mounayer, Superintendent of Education Monthly Report
 - We are in the final stages of our Anti-Sex Trafficking training plan. Our plan included creating a policy and procedure completed in the 2021 -2022 school year. The second component is student training in the fall, and the last component is staff training. To complete the plan, we provide Anti-Sex Trafficking training to all our staff through a video that CODE created. The footage includes Canadian content, explains the steps of sex trafficking and gives information on the luring process and the signs to look for if a child is sex trafficked. This training complies with the Ontario Ministry of Education Policy/Program Memorandum 166.



iii. Paul Tsekouras, Superintendent of Education Monthly Report

SNCDSB will offer a Grade 9 Reach Ahead Pilot to SNCDSB. Grade 8 students this summer as part of our Summer Learning Programming. The course being offered is Learning Strategies (GLS10). The learning goals of this course include students learning how to relate to others, manage resources, become responsible members of society, and develop interpersonal skills and practical skills related to daily life. It will also support students in developing essential skills in navigating online tools and a learning management system. GLS10 will be offered virtually online with synchronous and asynchronous instruction from July 4 - 28, 2023. The program will be offered using the D2L platform. The D2L is a standard platform used across the province for online learning. Currently, we have seven students enrolled in the Reach Ahead Pilot Program. It was noted when advertising the program it would have been beneficial to be specific on the synchronous time so students can register even if they are working. This will be reposted and shared with the Grade 8 students.
