Professional Learning Update

1. Professional Learning in Special Education - 2022-2023

Kerry wanted to give everyone a glance at all of the learning opportunities that occurred this year. Initially, we didn't think there would be many opportunities available because of short staffing/release time, etc. Still, opportunities came from having virtual options such as RBT courses, BMS training, Geneva Autism Training Program, etc.

It was very exciting to be able to do more than initially expected, and having the option of Zoom made things easier and more efficient.

Tracy was unable to attend but asked Kerry to share the following:

Children's Mental Health Week was incredible throughout the Board, with many activities led by students with the assistance of the Positive Behavioural Support

Workers. The DILICO Health Fair also had a wonderful impact on the students who could attend. The level of engagement was amazing.

Children's Centre Thunder Bay has entered into a Fee For Service Agreement with SNCDSB and has seen a lot of referrals. Uptake has been a lot quicker than other current Service Providers due to staffing shortages, so the services through Children's Centre Thunder Bay are greatly appreciated.

Proposed Changes to Special Education Plan 2023

Proposed changes went out to everyone for feedback. Minimal feedback was received, so only a few minor changes have occurred.

On the Contents Page - LHIN and CCAC need to be removed, and North of Superior Counselling Programs needs to be added.

Early Identification Procedures & Intervention Strategies - we have moved to two core programs - Heggerty and Lexia Core5 Reading.

The Identification, Placement Review Committee (IPRC) Process and Appeals -Ontario Special Education Tribunals - no in-person services available as they now offer services virtually - mailing address and phone number have changed.

The Identification, Placement Review Committee (IPRC) Process and Appeals our Board has gone from 51 to 56 identifications as a result of more assessments being done - has also led us to discover that some students are not identified as having learning disability but have gaps as a result of covid.

3. Update on Summer Learning 2023, including support for students with Special Education Needs

Kerry shared that we are moving forward with the program - we have 27 children registered for Summer Learning with a good span from K-8 across all schools.

We have advertised for Reach Ahead Tutor and Summer Learning Lead and will offer summer learning credit.

TinyEYE - 11 students are registered for language therapy.

George Jeffrey Children's Centre and Ignite are conducting transition programs to assist children with special needs transitioning back into school in September.

4. EQAO 2023

Update - testing is to be done and submitted by June 14th, and we are currently on

track to be fully completed by that date.

5. <u>School Year Calendar 2023-2024</u>

First day back to school is September 5, 2023. The first PD days are August 31 and September 1. The first PD day will be a Boardwide day where all staff will join together face to face. Principals and admin assistants are back on August 24.

Tiered Intervention was launched in Windsor in 2014 with school-based Occupational Therapists. George Jeffrey Children's Centre will be launching Tiered Intervention in a select number of schools in Thunder Bay. Tier 1 - focussed on SK, would have an OT in the classroom, and would do universal observation - waitlist review is occurring now (by finding out if the reason for referral still exists) - hoping to launch in the district in the future. Still, it will need to look different than in Thunder Bay.

George Jeffrey has two SLP students right now and is trying to take on students as it will support recruitment.

Summer Recreation Program is open to any client of George Jeffrey's (e.g. bike clinic every Thursday).

Behaviour Support - Registered Behaviour Therapist work is done with Our Lady of Lourdes Catholic School over the summer.

The Augmentative Team has entered into a relationship with FireFly and is

providing mentorship to become a general clinic.
