## **Business Arising Out of Minutes**

## **Professional Learning Update**

1. <u>Literacy Presentation</u> - Angela Gainer

A. Gainer shared a presentation on the new revised Language curriculum. The revised curriculum is also available as a download on the Ministry website. The Ministry wants to ensure that our students have enhanced spoken language comprehension. The four strands have been structured differently. A. Gainer shared the updated strands in Language. A. Gainer has been visiting all schools to assist with the new curriculum implementation for students. There are updates to the student report cards with only mark now for Language. There is a parent guide available online as well.

### **New Business**

1. Mental Health Update - Tracy Bryson

Bullying Awareness Week is coming up. We have shared information and resources with schools to raise awareness of this upcoming event. We are working on the Implementation of the Mental Health LIT modules for grades 7 and 8. We are working on a training plan for implementing these modules. PPM 169 on student mental health will be addressed at the next PD day in November.

#### 2. Speech-Language Therapy 2023-2024

We continue to work with George Jeffrey Children's Centre for our students receiving services (e.g. Speech & Language, Augmentative Communication). We have contracted TinyEYE Therapy Services and Superior Speech Services to assist with consistent weekly Speech Language Therapy. Our needs are increasing consistently across our Board. We currently have 52 students involved in a fee-for-service program.

#### 3. Psychoeducational Assessments 2023-2024 School Year

We did receive funding from the Ministry of Education for psychoeducational assessments in the amount of \$101,000, which can also be used for psychology assessments. We still have a Partnership with Dr. Sarah Sinclair, and she has been seeing our referral students in Thunder Bay because we do not have staff available to come to our area.

# 4. Professional Learning Update: Geneva Centre, Special Education AQ, and Confederation College

We have funds available for the above for our staff. We used this funding for courses through the Geneva Centre. We have 12 educators completing ABA level one at the moment, with additional staff interested. We have received Support from the Ministry for staff to take Special Education qualifications. We have partnered with Confederation College partnering with 16 Educational Assistants starting module one within our system.

- After School Skills Development Funding
  We have received funding from the Ministry of Education for this program. We have four schools currently operating this program.
